### **Annual Invitation to Participate in Auction of Quarterly System Entry Capacity**

National Grid invites you to take part in the 2019 annual Quarterly System Entry Capacity (QSEC) auction which will take place on Business Days between **18<sup>th</sup> March 2019** and **29<sup>th</sup> March 2019**.<sup>1</sup>

The auction is for Quarterly Firm NTS Entry Capacity for the transaction period **1<sup>st</sup> October 2020 to 30<sup>th</sup> September 2035**. Users can make applications for each calendar quarter within this period.

The provisions of the Uniform Network Code (UNC)<sup>2</sup> shall apply to this invitation, the 2019 auction for QSEC and any bids made and rejected or accepted pursuant to such auction, and any subsequent allocation of QSEC. Words and expressions which are capitalised but not defined in this invitation but which are defined in the UNC shall have the meanings given to them in the UNC.

Please refer to the Joint Office website (<http://www.gasgovernance.co.uk/livemods>) with regards to any modification of the UNC which may affect capacity during the transaction period.

As you may be aware, on the 20<sup>th</sup> December 2018 Ofgem rejected Mod 0621 (and all its alternates) – Amendments to Gas Transmission Charging Regime. Ofgem set out its reasons for the rejection here <http://www.gasgovernance.co.uk/0621>. The remaining provisions of the Tariff Network Code have an implementation date of 31<sup>st</sup> May 2019 and market participants should keep up to date and engage with how the Tariff Network Code should be reflected in the UNC via the Joint Office <http://www.gasgovernance.co.uk/livemods>.

Each bidding window in the QSEC auction will commence at 08:00 and close at 17:00 on each day specified below, subject to the stability measure being reached.<sup>3</sup> A QSEC bid may be withdrawn or amended until but not after 17:00 on each day.

## **Auction Timing**

National Grid will conduct the annual QSEC auction between 18<sup>th</sup> March 2019 and 29<sup>th</sup> March 2019 on the annual invitation dates listed below.

- **Monday 18<sup>th</sup> March**
- **Tuesday 19<sup>th</sup> March**
- **Wednesday 20<sup>th</sup> March**
- **Thursday 21<sup>st</sup> March**
- **Friday 22<sup>nd</sup> March**
  
- **Monday 25<sup>th</sup> March**
- **Tuesday 26<sup>th</sup> March**
- **Wednesday 27<sup>th</sup> March**
- **Thursday 28<sup>th</sup> March**
- **Friday 29<sup>th</sup> March**

National Grid shall close the annual QSEC auction on the last date listed, or before if the stability measure is reached.<sup>4</sup> The earliest this can occur is after Interim Bid Window 2 (IBW2) from 19<sup>th</sup> March 2019 onwards.

National Grid reserves the right to amend the auction timings and withdraw and re-issue the auction invitation. Furthermore, although unlikely, National Grid reserves the right to raise UNC Modifications, requesting urgency or otherwise.

## **Entry Capacity Regime**

It is a User's responsibility to understand the NTS Entry Capacity regime, determine a strategy and bid accordingly. For further information on the regime and QSEC auctions please refer to Appendix 3 onwards.

Please refer to the Joint Office website (<http://www.gasgovernance.co.uk/livemods>) with regards to any outstanding modifications which may affect capacity during this transaction period.

## **Entry Capacity Retainers**

In accordance with UNC TPD Section B2.15 and in particular the NTS Entry Capacity Substitution Methodology Statement (ECS), National Grid opened the retainer window on 15<sup>th</sup> and 17<sup>th</sup> January 2019, for Shippers to participate and take out a retainer at Aggregated System Entry Points (ASEPs) where they wanted to exclude available Entry Capacity from being treated as Substitutable Capacity<sup>5</sup> without having to buy it.

There were no retainers requested during the retainer windows on the dates above.

## **NTS Entry Capacity Offered**

National Grid invites offers in respect of the Unsold NTS Entry Capacity, as shown in Appendix 2.<sup>6</sup>

Requests for Incremental Obligated Entry Capacity that cannot be met through substitution may be allocated as Non-Obligated Incremental Entry Capacity at the sole discretion of National Grid.

## **Entry Capacity Substitution**

The NTS Entry Capacity Substitution Methodology Statement<sup>7</sup> (ECS) is available on the National Grid website via <https://www.nationalgrid.com/uk/gas/charging-and-methodologies/methodologies>

The principle of NTS Entry Capacity Substitution may be applied to meet demand for Incremental Obligated Entry Capacity (IOEC) in the March 2019 QSEC.

The latest version of the ECS reduces the substitution lead times from Y+4 to Y+2 (where Y is the current Gas Year). The updated versions of the ECS can be found via the above link.

Entry Capacity Substitution means that where IOEC is required, this should first be met by reducing available obligated entry capacity at other ASEPs (the “donor” ASEPs) where capacity is unsold and not otherwise excluded from substitution, before undertaking investment in new infrastructure. The result of this is that, when the substitution obligation is applied, NTS Entry Capacity that is not booked can be moved to other (“recipient”) ASEPs and will not be available as unsold obligated capacity at the original (donor) ASEP in future auctions. In addition to this, capacity that has been reserved under the new PARCA process will be excluded from substitution.

Whilst National Grid may be able to satisfy a request for capacity via the release of non-obligated capacity or via substitution the only way to guarantee release of incremental capacity is via the PARCA process.

### **Information Provision**

Information will be published by National Grid after each Interim Bid Window (IBW) on each Business Day the auction remains open, for each Aggregate System Entry Point (ASEP) and each relevant quarter. This can be found on Gemini report screens (Product>Publish Results>MoS Results>screens) and will be available by 8pm (as per UNC TPD Section B.2.14.1), and on the National Grid website as soon as practicable via

### **Reserve/Incremental Prices**

On 18<sup>th</sup> January 2019 National Grid issued the Statement of Gas Transmission Transportation Charges in which are detailed the incremental price steps that apply to the QSEC auction. Appendix D of the statement contains the Entry Capacity reserve prices together with the price steps for each level of incremental capacity for use in the QSEC auction, while Appendix E covers the estimated project values.
