

UNCC Update on Issuing Revised Notices of Implementation Following Approval of UNC Modification 0548 “Project Nexus – deferral of Implementation Date”

The following provides a brief summary relating to Revised Notices of Implementation for the ‘core’ Project Nexus modifications 0432, 0434 and 0440 and also Project Nexus aligned modifications 0445, 0473, 0514, 0515S, 0516S, 0518S (see note below) and 0523S on 18 September 2015.

Revised Notices of Implementation **0432 - Project Nexus – Gas Demand Estimation, Allocation, Settlement and Reconciliation reform**, **0434 – Project Nexus – Retrospective Adjustment** and **0440 – Project Nexus – iGT Single Service Provision** now read as ‘effective 05:00 hours on 01/10/2016’.

Revised Notice of Implementation **0445 – Amendment to the arrangements for Daily Metered Supply Point Capacity** now reads as ‘effective on the Project Nexus Implementation Date’.

Revised Notice of Implementation **0473 – Project Nexus – Allocation of Unidentified Gas** has NOT required an updated document as the current published notice already stipulated ‘effective on the Project Nexus Implementation Date’.

Revised Notice of Implementation **0514 – Extending the Daily Metered ‘voluntary’ service to Project Nexus Implementation Date plus six months** now reads as ‘effective on the Project Nexus Implementation Date’.

Revised Notice of Implementation **0515S – Resolution timescales for SRVs and USRVs following Project Nexus Implementation** has NOT required an updated document as the modification is already implemented (effective 06:00hrs on 13/03/2015).

Revised Notice of Implementation **0516S – Project Nexus – Information provision by large Customers to aid understanding of site characteristics** has NOT required an updated document as the current published notice already stipulated ‘effective on the Project Nexus Implementation Date’.

Revised Notice of Implementation **0523S – Supply Point Registration – Facilitation of ‘faster switching’ for Shared Supply Meter Points** has NOT required an updated document as the current published notice already stipulated ‘effective on the Project Nexus Implementation Date’.

FOR UNCC CONSIDERATION

The only remaining modification for (UNCC) consideration is **0518S – Shipper Verification of meter and address details following system meter removals** which has the following statement included within the published Notice of Implementation:

“Dear Colleague,

Please note that Modification 0518S will be implemented with effect from 05:00hrs on a date to be confirmed.

It is anticipated that the implementation date will be notified in advance to the Uniform Network Code Committee to allow Shipper Users to put processes in place and that this date will be after the Project Nexus Implementation Date.....”

Chris Warner has indicated that the restriction envisaged at the time has been removed by the deferral of the Nexus implementation date and, as a result, 0518S should be implemented at 05:00 on 01 October 2016.

UNCC approval is sought for this amendment so that a Revised Notice of Implementation can be issued.
