Topics Activity

The Following Topics were reviewed:

008TR **Entry Capacity**

On 3 May National Grid NTS submitted a presentation on Transfers and Trading between ASEPs. This included two draft Modification Proposals and referred to a Methodology Statement circulated prior to the meeting. National Grid NTS gave notice that it intended to withdraw Proposal 0133 and table two new Proposals for which it would seek Urgent processes.

On 9 May a further Workstream discussed Transfers and Trading. In addition to the potential UNC Proposals discussed on 3 May 2007, Ofgem gave a presentation which set-out the relevant obligations on National Grid NTS.

019TR **Gas Emergency Cashout Arrangements**

The Workstream discussed a draft Proposal from National Grid and agreed that a Proposal substantially of that form would be sufficiently developed to proceed to consultation

020TR **Gas Quality**

The first meeting of this Topic Group was held which reviewed progress made on licence amendments, a blending feasibility study at Bacton and outlined the process required to deliver the commercial framework. It was agreed that, in order to deliver a commercial framework Proposal, three further meetings would be required.
