Matters for Network Code Committee's Attention

Notwithstanding whether this is a Class 1 or a Class 2 Modification, in respect of UK Link Modification 13829 "DN Interruption Reform", UK Link Committee members were unable to reach consensus on waiving the four month minimum notification period for a Class 2 UK Link Modification.

UK Link Modification No Consensus Reached

- 13829 'DN Interruption Reform'
Notwithstanding whether this is a Class 1 or a Class 2 Modification, the Transporters requested that the four month minimum notice for "operational only" changes be waived. The Committee declined to agree to this whilst there was uncertainty in respect of Ofgem's decision on Modification Proposal 0090.
