Current Known Threats or Issues Detail

Defence sites

The Ministry of Defence (MOD) are undertaking a comprehensive Defence Service Review. All of our sites that are based on Defence land are potentially at risk. Any site specific decisions about site closures will be communicated in future updates.

10/04/2013 - Church Fenton

It was announced on the 25th March that the site will close December 2013. We are waiting on information on the future of the land & the potential of our being able to remain on site.

This is a newly identified risk this quarter. Initial indications are that there is a suitable alternative site nearby at Bramham, but this will require upgrading to provide all of the elements required. We have asked the observations team to provide information to us on this and other stations as it becomes available and expect to present a paper to relevant parties later in the year.

Filton 03628 - No change

Agreement has been reached for us to remain on site until the end of 2013. There is potential for an extension into 2014 when the police will be changing their current location but still remaining on site long term. We are investigating the proposed new location and planned development information so that we can ensure site suitability before negotiating a long term lease.

Manchester, Hulme Library 99029 - No change

Rooftop site (not ideal from a data quality perspective). Health & Safety concerns have triggered search for a higher quality nearby replacement site.

A paper considering alternative sites, including a potential dedicated Manchester urban site is in preparation, and should be available shortly.

Southampton Oceanography Centre 99079

Rooftop site (not ideal from a data quality perspective). Lease in place for a rolling annual agreement where both sides can give 6 months notice to terminate the agreement.

St Athan 03716 - No change

There are ambitious plans to build a business park in the vicinity of the AWS that may require the relocation of either the wind mast or the weather station enclosure or even both. The building development plans are vast and it may prove difficult to find a suitable location on site. It is believed that funding concerns have mothballed the plans for the time being. We are keeping a watching brief.

Rostherne No2 - 03351

The observations at this site are now to be Rostherne No2, the permanent observation station. This replaces Rostherne, which was a temporary automated weather station on the same site. All services currently receiving Rostherne data will be seamlessly migrated to Rostherne No2, with no visible interruption or changes to files.

An additional long-term risk has also been identified for this site - the potential plans for stage 2 of the HS2 railway link were issued on the 28th January. The rail line would run directly through the new enclosure at Rostherne No2. We will keep an eye on developments.
