Modifications that are on this month's Panel agenda are:

### **New Modifications**

## Modification 0571A – Application of Ratchet Charges to Class 1 Supply Points and Class 2 with an AQ above 73,200kWhs

#### Proposed by Eon

Modification 0571, raised by Gazprom in January 2016, proposes (post go-live of the new market arrangements under Project Nexus) to limit the application of Ratchet Charges to Class 1 Supply Points, which includes mandatory Daily Metered sites and Network Sensitive Loads and whose operation may be material to the safe operation of the network.

0571A seeks to extend the applicability to include larger class 2 supply points, which have the many of the same obligations, and consequences, as class 1. The proposer believes it is therefore appropriate to treat the larger class 2 sites in the same way as class 1 with respect to ratchet charges.

The Proposer is not seeking self-governance status for this modification.

# Modification 0582 – Amendments to reflect separation in legal ownership of NTS and National Grid owned LDZs to facilitate the sale of National Grid's Gas Distribution Business

Proposed by National Grid Distribution

National Grid Gas plc intends to sell a majority stake in its Gas Distribution Business. The

new business would no longer be known as National Grid Gas Distribution. This modification proposes to modify the UNC to reflect the separation in ownership of the NTS and the 4 LDZs currently comprising National Grid Gas Distribution prior to completion of the sale process.

The Proposer is seeking self-governance status for this modification on the basis that the changes do not impact upon consumers or competition.

# Modification 0583 – Requiring an Opening Meter Reading at same User Confirmation

Proposed by National Grid Distribution (at short notice at Panel's discretion)

This Modification would require Users to provide an Opening Meter Reading in the event of a re-confirmation – i.e. the Proposing User is the Existing Registered User. Where such a reading has not been provided Transporters would create an estimated Opening Meter Reading.

The Proposer is seeking self-governance status for this modification on the basis that the changes do not impact upon consumers or competition.

### Self-Governance Implementation

#### Modification 0581S – Amending the Oxygen content limit specified in the Network Entry Agreements at Grain LNG

This enabling modification proposes to enable an increase to the oxygen content limit of gas permitted by the three relevant Network Entry Agreements at Grain LNG. The proposed level of 200ppm is to provide access to wider LNG cargoes. It is well within the Gas Safety (Management) Regulations limit (2000ppm) and is consistent with many other entry points.

The consultation is open until Friday 13 May. An update on respondents' views will be provided on the call.
