## Modification 0620 - Deferral of the UK Link Manual delivery date (further revision)

### Proposed by Cadent

This modification seeks to further amend the delivery date set out in the UNC for the revised Manual (Please this was deferred recently by Modification 0617S). It has since been identified that a further deferral of the implementation date to 13th October 2017 is necessary to provide sufficient time for the significant volume of changes to the Manual to be comprehensively reviewed by industry parties.

The Proposer is seeking self-governance status for this modification on the basis that it has no material impact on any of the self-governance criteria since it is a direct replacement for the existing version. In addition, the Proposer recommends that it should be issued directly to a brief consultation in order to ensure that the date can be amended before the current delivery date of 31 July 2017.

## Modification 0621 - Amendments to Gas Transmission Charging Regime

Proposed by National Grid NTS

This modification is proposing to amend the Gas Transmission Charging regime in order to better meet the relevant charging objectives and customer/stakeholder provided objectives for Gas Transmission Transportation charges and to deliver compliance with

relevant EU codes (notably the EU Tariff Code).

The Proposer is not seeking self-governance status for this modification on the basis that it may have a material impact upon the commercial activities associated with gas shipping or the transportation of gas. The proposer is recommending the modification should be assessed by a Workgroup.
