Awaiting Modification Details	Change Request progress is dependant on a respective Modification/UK Link Committee awaiting confirmation of Mod Status.
In Representation/Close Out DD/MM/YYYY	File Formats out for representation.
Representation outstanding	Representation closed out. Awaiting resolution on Shipper(s) representations to be resolved before proceeding for agreement.
Awaiting UKL Comm Agreement	Representation closed out. Awaiting UK Link committee agreement on potential implementation date.
