# 1 Summary

#### What

Where the Local Distribution Zone or Exit Zone of a Supply Meter Point is amended the Transportation Rates applicable will be amended. In order to ensure that the reconciliation utilises the correct rates it is proposed to enable the Central Data Service Provider (CDSP) to insert a Meter Reading at the effective date of the LDZ or EZ change.

#### Why

Prior to the Project Nexus Implementation Date a Shipper User would need to perform a same Shipper Confirmation (a 'reconfirmation') to change either the Local Distribution Zone or the Exit Zone. Shipper Users requested that this be performed following the Project Nexus Implementation Date without the need for the reconfirmation. This functionality now relies upon a Meter Reading being available for the effective date of such changes and therefore circa 600 amendments have not been processed.

Inserting a Meter Reading enables clear identification of the volume of gas attributed to the period prior to the LDZ or EZ change, and consequently the Transportation Rates applied for this period. This will enable Shipper Users to provide, in accordance with the prevailing Uniform Network Code Rules, the ability for the Shipper User to replace such Meter Reading.

This modification also refers to Supply Meter Points on iGT Networks.

#### How

Section M of the Uniform Network Code currently provides the circumstances that the CDSP will provide a reading. This modification proposes that in the event that the Local Distribution Zone (LDZ) or Exit Zone (EZ) is changed for a Supply Meter Point that the CDSP may insert a Meter Reading for the effective date of the change.

# 2 Governance

### Justification for [Fast Track] Self-Governance, Authority Direction or Urgency

This modification is proposed to be subject to self governance as it is not expected to have a material impact upon, or discriminate, against any parties. This modification relates to amendment of the Local Distribution Zone or Exit Zone for a Supply Meter Point and facilitates more transparent allocation of gas across variance periods.

#### **Requested Next Steps**

This modification should:

- be considered a non-material change and subject to self-governance
- be assessed by a Workgroup

Assessment by Workgroup is recommended to enable development of the modification.

# 3 Why Change?
