3. Issues

3.1. ISS 0070 – Consequences of SPAA Change Proposal 0443

Richard Pomroy (RP) explained that there was a meeting planned on 21/11/18 to discuss this area in more depth and he said that he would provide an update following this meeting. He added that the November meeting was the first of two meetings on this topic and that it would also subsequently be discussed at the DSC Change Management Committee as required. He said the January meeting would be of more interest to Shippers.

5. Any Other Business

5.1. AQ Backstop

Mark Jones (MJ) explained that he was thinking of raising a new Modification in relation to XRN4431 which had been implemented regarding the read process. He said there was an issue on the actual backstop date and how this would be carried forward.

A general discussion took place and David Addison (DA) said that currently when an AQ Correction was accepted a 'backstop date' was set. He then explained that this date would prevent an AQ being calculated using readings prior to the backstop date.

This backstop date is set as the effective date of the new AQ on UK Link systems. MJ then enquired whether it would be more appropriate to use the Meter Reading date provided for the Supply Meter Point in the C41 (or U01) record.

DA said he suspected that the Meter Reading was only provided for a reason where a reading has failed tolerance it can be submitted with the revised AQ requested, so it may not be applicable to all instances of AQ Corrections being submitted. It was agreed that more discussion and investigation was required regarding this matter.

6. Next Steps

BF drew attention to the fact the Distribution Workgroup meeting on 22 November 2018 would start at the later time of 11.00am due to a Panel discussion regarding the urgent modification.
