Moving on, CWi confirmed that National Grid would be looking to raise a new UNC Modification in time for submission to the 21 February 2019 Panel meeting (i.e. by close of play on Friday 08 February 2019 at the latest).

**Update:** When asked where this action originates from, JCx responded by suggesting that it is in relation to her previous enquiry relating to where within Code there are any references to 'PARCA Applications'.

When trying to ascertain what is required in terms of the 'standard period' reference (i.e. is it in the context of the security amount in which case that resides within UNC TPD Section Y), JCx suggested that it relates more to what happens to the security amount beyond the 28 day acceptance period – it is felt that further clarification is needed in order to avoid unnecessary confusion amongst various industry parties. **Carried Forward**
