5.1. UNC Election Process

CS reminded Workgroup participants of the UNC Election process and provided a brief walkthrough of the guidelines for the UNC Shipper Representative Appointment Process which are published on the Joint Office website at:

He reminded participants that UNC Panel appointments are for 2 years and all other appointments run from 01 October to 30 September annually. A UNCC change was discussed at the Modification Panel in relation to PAC appointments and a decision is awaited on this.

He also provided a reminder on the timescales signalling that the Single Point of Contacts need to update their contacts by the end of June. The Nomination process will then commence from 01 July lasting for no more than 3 weeks. If elections are required these will be held from 01 August and notification of the elected candidate will be issued by 01 September with elected members taking up positions from 01 October.

In addition, he highlighted the current vacancies and indicated that where a mid-year process is necessary this will be triggered via an expression of interest and will be for the residual of the current gas year.
