1. Introduction and Status Review

Steve Mulinganie (SM) asked whether PG would be looking to review Legal Text arrangements as well and was informed that this topic needed a more focused review, as the Governance Workgroup can only hold a general review, Legal Text possibly needs to be considered with a focused scoped in a separate Workgroup. The consultation is proposing changes to the data reporting requirements for the industry. RP raised the question as to whether BEIS were able to rasie such a Modification. The Workgroup also expressed concerns as to whether Xoserve would be able to deliver the data requested.

RH will be sending out the BEIS email to industry to publicise the consultation for their information.
