# 2. Offtake Communications Document Amendments

Mathew Newman (MN) provided the Background in relation to the recent DSR reforms (Modifications 0844 and 0845). The existing arrangements are for National Gas Transmission (NGT) to communicate to the relevant DNOs if consumers within their network have exercised DSR. MN proposed two amendments and provided a table with an overview of the changes required. A copy of the document was provided ahead of the meeting to allow consideration and approval. MN presented the Committee with a marked-up version of the Offtake Communications Document for approval.

The Committee considered the revisions proposed by NGT but a number of the delegates present were not in a position to provide a view further to that previously provided at other forums.

The Committee considered approving the document via email, as a majority vote was not reached.
