December updates

Key revenue changes

- Plt Updated to reflect November OBR forecasts in line with Ofgem's inflation methodology.
- "Base Rev" Updated Price Control Deliverables, Uncertainty Mechanism's, and Totex classification aligned to Ofgem's view in addition to super tax forecasts
- PTt Forecasted updates to CDSP, NTS, & confirmation of Ofgem's minded to position regarding SoLR claims





December updates continued

Risks and Sensitivities

- Wholesale gas prices are currently subject to volatility. The shrinkage cost forecast, which is driven by wholesale gas prices, is therefore subject to material change as we move through 2023/24. Current view from early Dec is a price of 101.5p per therm against the budget price of 292.74p per therm
- Ofgem has confirmed its final position regarding SoLR. Due to changes in claims we expect to charge £1.4m and £0.6m to shippers in 24/25 in Southern and Scotland respectively
- To adhere to SGNs five year tariff forecast obligation under the UNC, SGN have included a forecast for the first year of the GD3 price control. As discussions with Ofgem, regarding GD3 have not yet begun we have no basis to include any-forecasts, as a result SGN have taken the approach of rolling forward revenue levels from 2025/26. This approach does not represent SGNs view of GD3 revenues. These revenues could be materially different to the figures quoted and any use of 2026/27 tariff forecast should be done so recognising this uncertainty.
