# Phase 1 (12<sup>th</sup> March to 20<sup>th</sup> August)

The first phase of the AQ Review, where the AQ Calculation process takes place, has been completed successfully.

### Phase 2 (27<sup>th</sup> August – 14<sup>th</sup> September)

During the second phase, the Supply Point/Offer Review processes and new EUC changes takes place and shipper update files are sent.

### Phase 3 (22<sup>nd</sup> September – 29<sup>th</sup> September)

The third phase sees the start of the busiest time for the AQ Review process. On 23<sup>rd</sup> September, all SPA file processing will be put on hold to allow for the preparation for uploading data onto the UK Link system. The following list details the files that will be delayed along with the expected completion date/time for catch up.

- Transfer of ownership (early morning SPA suite and TRF files) to be held on 23<sup>rd</sup> Sept. Catch up is expected to complete on 24<sup>th</sup> Sept
- NDM AQ/SOQ data to Gemini (AAQ/MDS) to be held on 23<sup>rd</sup> Sept. Single catch up for 23<sup>rd</sup>/24<sup>th</sup> Sept is expected to complete on 24<sup>th</sup> Sept
- UMR file processing to be held on 23<sup>rd</sup> Sept. Catch up is expected to complete on 24<sup>th</sup> Sept
- RGMA file (JOB/UPD) processing to be held on 23<sup>rd</sup> Sept. Single catch up for 23<sup>rd</sup>/24<sup>th</sup> Sept is expected to complete on 24<sup>th</sup> Sept

- UMR file processing to be held on 1<sup>st</sup> Oct. Catch up is expected to complete on 2<sup>nd</sup> Oct
- RGMA file (JOB/UPD) processing to be held on 1<sup>st</sup> Oct. Catch up is expected to complete on 4<sup>th</sup> Oct
- RGMA file (MAM) processing files to be held on 1<sup>st</sup> Oct. Catch up is expected to complete on 2nd Oct
- SPGMT (Inv95 Supply Point Group) to be held on 1<sup>st</sup> Oct. Catch up is expected to complete on 5<sup>th</sup> Oct

During these periods, the industry will receive delayed responses to any files sent to xoserve. Once the processes re-engage the held files will be processed in chronological order until real-time processing resumes.
