- Build & system testing continue. System testing progress has been slower than expected. Mitigating options being analysed.

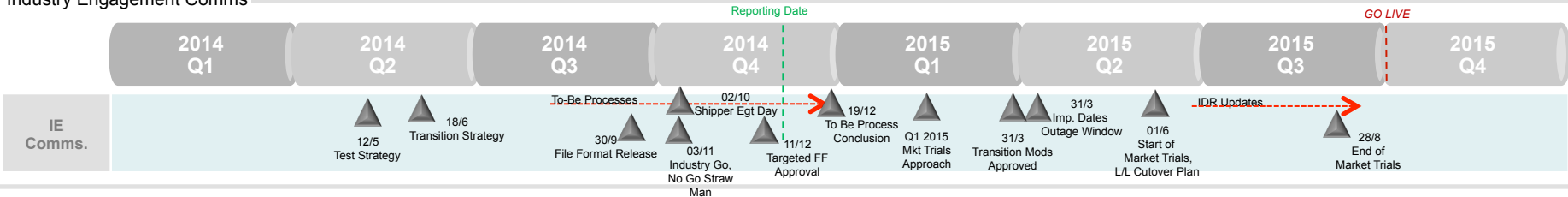
Recent Achievements

- 3x Shipper reps walkthroughs held to help facilitate the File Format Consultation process.
- To Be Process Walkthroughs continue in line with agreed plan
- iGT end to end process walkthrough brought forward from December following feedback through UKLC meetings
- Gemini Consequential Change walkthrough meeting held.
- Non-shipper file formats distributed
- Two Market Trials Working Groups have been held with industry participants

<b>Data Cleanse:</b> There is a risk that data cleanse activities will not complete in the required timescales, due to progress to date on settlement data cleanse activities and the unknown quantity of data cleanse required as outputs from Source to Target mapping and Data Migration testing.	Feb 2015	Data Cleansing Forum has increased its frequency to monthly. Xoserve to prioritise / categorise data outputs from Source to Target to ensure Industry can focus in the most effective areas.
<b>File Formats:</b> There is a risk that any changes to file formats as a result of the UKLC approval process (formal consultation and reps) may impact on the ability of the industry to deliver by Oct 2015 due to design re-work.	Nov 2014	Walkthroughs of the Shipper Reps have been conducted. The sessions have enabled Xoserve to explain responses to representations in detail and provide rationale for specific design decisions.
<b>Market Testing:</b> Risk that Market Trials is insufficient in length, too late within the programme, and participants may not be ready in time to take part.	June 2015	Market Trials and UAT hard link removed. Consideration being given through the Market Trials Working Group as to what activities can be started early. Supporting this, the start of Market Connectivity Testing has been brought forward to 05/05/15.

There is a risk that, due to the industry governance and approval process of modifications not being completed, changes will be required which will impact the design and could impact project timelines.	Ongoing	Change control process in place and potential changes discussed at EU PMB. A number of changes have been incorporated with others being analysed for delivery in 2016.
A solution is required to enable data exchange between Adjacent Transmission System Operators (TSO) and Gemini, given that TSOs are not using the assumed mechanism.	Apr 2015	A B2B solution is under selection following analysis of options.
