## **Change Overview**

Ofgem's final decision for the Gas Significant Code Review (SCR) was published on the 23rd September 2014. This documented the changes required to the Gas Deficit Emergency (GDE) Cashout arrangements and the introduction of arrangements that recompense End Consumers for involuntary demand-side interruption of supply during a GDE.


These changes to the UNC are required to be implemented on the 1<sup>st</sup> October 2015.

To support the requirements of the GDE Cashout arrangements, Xoserve is developing a solution to calculate the charges for MPRNs that are eligible for compensation as a result of a Gas supply emergency.

Please note it is expected a GDE event will be very rare, potentially this will never occur.

## Charge Types & Supporting Info

- The Energy Balancing Invoice (.IDB) will have one new record type 'D18' to reflect charges.
- 3 primary and 3 adjustment charge types in total.
- Charges will scheduled as per existing Energy Balancing Invoice.
- All charges and compensation payments will be issued to Shippers.


