4.2 Energy Balancing Credit Rules

MC confirmed that Xoserve have reviewed the Energy Balancing Credit Rules and are currently working on the draft amendment, which will be ready for review by the end of this week. He explained that the amended rules will need to be effective from the 01 April 2017 and members will need to have approved the changes with a shortened notice period.

4.3 Bank Minimum Ratings

RF enquired whether it would be worth EBCC members looking at the minimum ratings in the Energy Balancing Credit Rules and whether the current rating was still suitable or should be reduced.

MC confirmed that every April and October Xoserve examine ratings and the spread of risk taking into account any financial shifts in recent years. He concurred a review on a regular basis is worthwhile however at the moment Xoserve have not received any significant pushback from users to reduce the ratings and to allow consideration of additional service providers.

Xoserve agreed to provide some analysis with a view of reviewing the data at the face to face meeting in April.
