# EH/877/DA - 2 - SMS Text Message Service

As discussed at the October UK link Committee Meeting, xoserve is seeking contact details of users who would wish to receive notification of late deviations from the UKLink Implementation Plan via SMS message. It is anticipated that this will be used only where an implementation is unsuccessful or has been withdrawn at short notice. It is not intended to be used to notify Users of successful implementations.

The SMS message is intended to provide Users with as much notice as possible in such circumstances, but by the nature of the medium will be unable to convey much detail regarding the reasons for deviation or any potential rescheduling. This message will not constitute a code communication, so where it is issued it will be in addition to the communication described in Uniform Network Code where Users are notified on the business day following a failed implementation (U 8.6.3).
