




Testing Stages

 - Connected System Integration
 - System performance
 - External User Trials

Training



Connected System Integration



There is a new requirement to create new interfaces with adjacent TSOs this interface requires testing

Build

- The PRISMA interface to NG systems will also be tested to ensure it is fully robust prior to GB IPs going live on the system
- The new ENTSOG Transparency platform is now live, changes will need tested to ensure we continue to meet our transparency reporting obligations
