Summary

User Confidence Testing (UCT) has completed and the project is currently running well through the Early View API Trials. Training has started for shippers.

Progress This Period

- 1. UCT has completed. A UCT completion report is in progress for circulation to shippers. A two week Regression Testing period is planned before Shipper Trials in order to test some of the defects found during UCT.
- 2. The Early View API Trial is in the main progressing successfully, excepting an issue resolved with the Bulk Upload/Download facility. A temporary fix has been followed up with a permanent fix, allowing the continued use of this functionality. Feedback on the support being provided for the trial has been positive with shippers making good use of a web forum provided for the period.
- 3. Shipper training started w/c 18th April with 'train the trainer' courses commencing the following week. Feedback is being fed into the project and captured on the Gemini website for shippers. Initial feedback on the system is encouraging, excepting issues resulting from the internet environment used for training only.
- 4. The Shipper User/Training Manual and presentations have been published on the Gemini website
- 5. The Shipper Working Group of 5th May discussed Shipper Acceptance Criteria Validation, Gemini Outage Requirements, Multiple BA Functionality and Gemini Batch Processes. It is recognised that Gemini implementation will require challenging outage periods.

Plans for Next Period

- 1. Shipper Forum to be held on the 11th May to include Shipper Acceptance Criteria Validation, Gemini Outage Requirements, Multiple BA Functionality and Gemini Batch Processes.
- 2. UK Link Committee to be held 19th May.
