0063 and 0064 – To Nov 2005 Panel (first discussion).

Nature of Proposed Governance

- Publish document on industry website.
- Version Control.
- Transporters able to propose change to all documents named.
- Users able to propose change to:
 - Network Code Operations Reporting Manual
 - Code Credit Rules
 - Network Code Validation Rules
 - GRE Invoice Query Incentive Scheme Methodology
 - CSEP Ancillary Agreement
- Approval of change by majority vote of UNC Committee (able to be referred to sub-committee by majority vote).
- If UNC fails to make a decision, change subject to Modification Procedures unless Committee determines it should not be.

National Grid (Distribution) 'General' View

- Concern that Ofgem is removed from the decision to implement (where Committee decides).
- Can preclude open debate in Workstream.
- Further clarification required in relation to nature of governance:
 - reason for referral to sub-committee.
 - reasons for not recommending Modification Procedures
- Concern that not all provisions of the documents are 'procedural' higher level of governance required for 'non-procedural'?
- Mod Process required by licence. Proposals advocate a different change process.
- Recognition that 0730 established concept of UNC Committee sanction of change – but further development required.
- Sympathy with concerns regarding visibility of documents, a greater role for Users in the change process and industry fragmentation.

0053 – Network Code Operations Reporting Manual

- Current change process:
 - > UNC Committee Vote (recourse to Ofgem).
- Points for consideration:
 - > Document is a reporting manual and not the reports themselves
 - > Information issued by Transmission.
- UKD Position: Concerned because -
 - Ofgem removed from decision.
 - Lack of clarity in respect of 'Code Procedures'.



0055 – System Management Principles

- Current change process:
 - Transporter Licence determined consultation.
- Points for consideration:
 - Superior nature of licence overrides UNC.
 - > To implement would require change to Transporter Licences.
 - > 'Validity' of Proposal.
- UKD Position: Concerned because -
 - Change process already established in Transporter Licence.
 - Conflict exists.



0056 – Code Credit Rules

• Current change process:

Revised by the relevant Transporter – no consultation required.

- Points for consideration:
 - Individual Transporter arrangements one per DN.
 - > A number of aspects of the current rules are subject of Mod Proposals.
- UKD Position: No particular concern
 - But need to be aware of outcome of Credit Modification Proposals

0057 – Incremental Entry Capacity Release Methodology Statement (IECR)

• Current change process:

> Transporter Licence determined: revised only with the consent of Ofgem.

- Points for consideration:
 - > Superior nature of licence above UNC.
 - > To implement would require change to Transporter Licences.
 - > 'Validity' of Proposal.
- UKD Position: Concerned because
 - Change process already detailed in Transporter Licence.

0059 – Network Code Validation Rules

- Current change process:
 - > Consultation with UNC Committee (or relevant sub-committee).
 - ➤ 3 months notice for change
 - Subject to Condition A11(18) Disapproval by Ofgem.
- UKD Position: Concerned because -
 - Ofgem removed (by exception) from decision.
 - Complex change proposal could be approved by UNC Committee simple majority.
 - Lack of clarity in respect of 'Code Procedures'.
 - Lack of clarity in respect of implementation provisions eg. Could significant changes be implemented with little or no notice?

0063 – GRE Invoice Query Incentive Scheme Methodology

- Current change process:
 - > Agreed with Ofgem.
- UKD Position: Concerned because -
 - > Ofgem removed from decision.
 - > Lack of clarity in respect of 'Code Procedures'.
 - ➢ Involves calculation of liabilities final say should be with Ofgem.



0064 – CSEP Ancillary Agreement

- Current change process:
 - > Modification as per UNC Modification Rules.
- UKD Position: Concerned because -
 - > Proposes a lower level of governance than currently exists.
 - > Ofgem removed from decision.
 - Lack of clarity in respect of 'Code Procedures'.



Summary

- National Grid (UKD) sympathetic to a review of the change mechanisms in respect of UNC Ancillary Documents.
- UKD is concerned with a number of the proposals as currently drafted.
- UKD would support a review involving consideration of
 - optimum governance arrangements and consideration of the necessity of recourse to Ofgem,
 - the 'rights' of document owner to raise change,
 - the 'rights' of others to raise change,
 - the nature of concerns with current process.
- Objective: a transparent and consistent change mechanism.
