LEGAL DRAFTING FOR MODIFICATIONS 0432, 0434 AND 0453 - EXPLANATORY NOTE

The full extent of the proposed changes for Modification 0432 and 0453 are those shown in (i) the eight PDFs for TPD Sections A, C, E, F, G, H, M and S and (ii) the document headed 'Modification 0432 – Non Core Legal Drafting for TPD Sections B, J, N, Q, V and X, OAD Section H, TD Section IIC and GT Section C which accompany this explanatory note.

For the avoidance of doubt in the eight PDFs for TPD Sections A, C, E, F, G, H, M and S the proposed additions are shown underlined and the proposed deletions are shown in strike-through.

1 Modifications 0432 and 0453

- 1.1 The core changes for Modification 0432 and the changes for Modification 0453 are shown in marked-up versions of TPD Sections A, C, E, F, G, H, M and S.
- 1.2 The changes are shown against version 4.26 of the relevant sections of TPD (version 4.28 for Section G).
- 1.3 Version 4.26 (and 4.28 for Section G) does not include Modification 0428 changes; therefore:
 - Modification 0428 changes which are independent of Modification 0432 and 0453 changes are also shown in the mark-up, e.g. Section A4.2.1. This helps with reading the Modification 0432 and 0453 changes;
 - (b) where Modification 0432 and 0453 change text previously changed by Modification 0428:
 - the changes are shown against version 4.26 (or 4.28 for Section G); they are not shown against an updated version 4.26 (or 4.28 for Section G) which includes Modification 0428 changes (this cannot be done in the absence of a version including the Modification 0428 changes);
 - see Section A4.1.4 as an example of this. Under Modification 0428 the paragraph is deleted, under Modification 0432 it is amended. So for Modification 0432 changes we show the amendment to version 4.26 (therefore in this example the change is not shown as including the addition of a new paragraph but rather as the amendment to an existing paragraph);
 - (c) changes for Modification 0432 and 0453 have been made consistent with Modification 0428, e.g. the changes reflect the principle that a single Supply Meter Point is comprised in a Supply Point; and
 - (d) in some limited instances changes made for Modification 0428 have been reversed by Modification 0432; in the main where for Modification 0432 purposes it is appropriate to draft at the Supply Meter Point rather than Supply Point level, e.g. we revert to NDM Supply Meter Point Demand as the defined term in Section H2.1.1.
- 1.4 The non-core changes for Modification 0432 are shown in a stand-alone document as track changes against the relevant paragraphs of Sections of TPD, OAD and GT.

2 Modification 0434

- 2.1 The changes are shown in a stand-alone document as track changes against the relevant paragraphs.
- 2.2 The changes are based on changes made for Modification 0432.
- 2.3 The changes have been made consistent with Modification 0428.
