Action 0432 11/03: a) All parties to consider providing a view as to their respective anticipated product line (options 1 to 4) take up including associated timelines; and to also b) consider if they believe an additional and separate legal text meeting would be appropriate.

Update: a) AM confirmed that as yet no views had been received and encouraged parties to at least provide a broad indication of potential product take up, so that systems requirements can be progressed. If no additional indications are received by March then Xoserve will work with whatever information it has – the industry may therefore have to recognise and concede that this involves an element of risk.

Action 0432 12/01 (revised): To develop three draft base case (market price) scenarios for consideration at the next meeting.

Update: SM reported that this was under discussion with ICoSS and Gareth Evans, and that a meeting with Ofgem (JD) had been planned for the following week. Feedback from the meeting would be brought to the next Workgroup meeting on 05 February 2013.

High, Medium and Low cases would be developed, and BM indicated that these might be brought forward for discussion by the end of February.
