<u>Draft Workgroup Report (v0.2) Development</u>

An onscreen review of the draft WGR (v0.2, dated 08 October 2013) was undertaken, with special attention being devoted to the relevant objectives and user pays sections.

In considering the user pays requirements it was noted that the views expressed during the similar (i.e. Gemini funding) discussions for Modification 0432 also apply here

A great deal of debate took place around the potential benefits case for the modification, as it is widely accepted that the value of the potential cost savings

involved are marginal (circa £2 million at best, which would potentially become even smaller should 0432 be rejected) – the consensus being that this modification relates more to the potential avoidance of costs and that any (true) benefits are related to quality, rather than being quantifiable in nature. It was recognised that this modification seeks simply to provide a systematised solution in place of current manual processes

Moving on to look at 'Implementation' a short discussion took place around the assumption that Modification 0432 would introduce individual meter point reconciliation at the SSP level. It was suggested that Ofgem would need to adopt a pragmatic approach to their consideration of 0432 and 0434. Concluding, a new action was assigned to AM to look to provide an example of the implications of adopting the LSP individual meter point reconciliation within the SSP market sector.
