4. Completion of Workgroup Report (inc. legal text sign off)

Prior to consideration of the (draft) Workgroup Report, SC provided a brief update on the progress of modification 0473A explaining that some work remains to be completed.

When asked, ARS indicated that he is unsure that the legal text for 0473A would be ready in time for either Mon/Tues next week. Responding, SM once again voiced his concern that any delay in progressing 0473A has a direct impact upon his own modification 0473. In looking at the options, SM enquired whether or not it would be feasible to de-couple the two modifications – LJ pointed out that this would not work as it would be very difficult to make a decision on 0473 without consideration of 0473A (and vice versa).

Parties briefly discussed whether to hold a teleconference meeting on Tuesday 16 September, but this was discounted when ARS could not commit to providing the legal text in time. SC also indicated that British Gas might have some amendments to make to their modification in the meantime.

Concluding the discussions, LJ advised that, in the absence of a completed Workgroup Report an extension to the Workgroup reporting date would now be requested at the 18 September Panel meeting.
