#### 1. Review of Minutes and Actions

## 1.1. Review of Minutes

The minutes of the previous meeting were accepted.

#### 1.2. Review of Actions

**0473 06/01:** Waters Wye Associates (GE) to provide a link to the EDF Energy Electricity Report and thereafter all parties to review the document and provide their views, where appropriate.

**Update:** BF explained that a link to the EDF Energy Electricity Report had been provided and included within the minutes of the last meeting. **Closed** 

**0473 06/02:** Waters Wye Associates (GE) & Northern Gas Networks (ARS) to seek a legal view on how the transitional table would be reflected in the guidance document and/or UNC.

**Update:** In the absence of GE, SM advised that consideration of the action remains ongoing. **Carried Forward** 

**0473 06/03:** *Linked to action 0473 06/02* – Northern Gas Networks (ARS) to confirm that the proposed solution is viable and thereafter ensure that the supporting legal text is 'fit for purpose'.

**Update:** BF advised that ARS had not provided an action update prior to the meeting. **Carried Forward** 

**0473 06/04:** All parties to review the 0473A Framework Document and provide their feedback in time for provision of amended version of the document in time for consideration at the next meeting.

**Update:** BF advised that amended versions of both the 0473A modification and framework document had been provided immediately prior to today's meeting taking place.

AM suggested that whilst he is happy to review the documents at today's meeting, he would anticipate providing more meaningful (Xoserve) feedback once he has had enough time to consider the changes in more detail. **Carried Forward** 

#### 2. Review of AUGE Guidelines

Consideration deferred.

#### 3. Review of 0473A Framework Document

#### 3.1 Modification 0473A Update

SC provided an onscreen overview of the more recent changes to the modification (v4.0, dated 06 June 2014) explaining that the principal change is to the table contained within Section 3 - Solution.

## 3.2 0473A Framework Document

Providing a brief onscreen review of the changes made to the 0473A Framework Document (v5.0, dated 18 June 2014), SC focused attention on the Section 5 changes and explained that comments/feedback from the previous meeting(s) had now been incorporated (where deemed appropriate) in to this latest iteration of the document.

The key discussion items not captured directly within the document are recorded as follows:

Paragraph 5.1.6(a) & (b) – reference changes only;

Paragraph 5.1.7 – it was suggested that the term 'equitably treated' may be better than 'equitably affected'. SC agreed to double check with her legal colleagues;

Paragraph 5.1.9 – adopts an 'open ended approach' with the earliest roll over of the data table (factors) after 12 months.

FC provided a brief overview of the proposed process timeline for 2015/16 arrangements. SC suggested that whilst discussions remain ongoing any feedback on this matter would be welcomed;

Paragraph 5.1.10 – some concerns voiced about the use of the term 'in line with' and the need to specify what the consultation process might be;

Paragraph 5.1.13 – questions asked about whether or not inclusion of iGTs is appropriate with AM suggesting that a defined term may also be required to clarify the matter;

Paragraph 5.1.22 – it was felt that use of the term 'approval' would be preferable to 'signed off'. SM suggested that there would be benefit in having an additional post approval statement / clause to enable the Committee to unpick a previous approval.

Feedback on whether a majority or unanimous vote would be appropriate for the rejection of the UGIE's findings by the Committee was requested. BF suggested that this is more related to how the Committee would disapprove the UGIEs findings and whether an appropriate test criteria has been adopted and followed (i.e. how best to sequence the events – test should precede approval and not the other way around);

In recognising that the document had been provided at very short notice, SC requested that parties take it away and consider providing their views / comments in time for consideration at the next meeting.

BF then asked JD for a view (based on Ofgem's decision on UNC Modification 0432) on how best to progress development of the modifications and the associated Workgroup Report findings and recommendations. Responding, JD highlighted the fact that Ofgem would be keen to see an informed solution that is more dynamic in nature, and not subjective, and which is based on undisputable evidence. In addition they would like to see a more intelligent approach to the transitional period than the adoption of fixed values for the table.

When asked, AM confirmed that currently there is not a view on the potential User Pays costs available as this is heavily dependent upon what specific deliverables the modification advocates.

When asked whether or not a changed marked version of the 0473A modification based on these latest discussions could be provided, SC indicated that she would look to provide one within the next 10 business days. However, she did point out that it is highly unlikely that the legal text would be ready in time for consideration at the next meeting. BF suggested that if British Gas could provide amended business rules to Northern Gas Networks as early as possible then they (NGN) could provide a more informed view around the provision of formal legal text.

## 4. Completion of Workgroup Report (inc. legal text sign off)

BF suggested that until the outstanding actions are completed for both modifications and amended modifications and legal text provided, further consideration of the draft (0473/0473A) Workgroup Report (v0.2, dated 20 May 2014) should be deferred until the next meeting – this suggested approach met with the approval of those present.

It was also agreed that the 'target' remains to present the Workgroup Report to the August Panel.
