2.0 Consideration of Legal Text and Commentary

BF advised that a formal request for legal text and supporting commentary had been made at the February UNC Panel meeting, in order to enable the Workgroup Report to be finalised.

DM confirmed that the (draft) legal text, as discussed at the previous meeting, could now be considered as final text.

Thereafter the Workgroup considered the legal text and plain English commentary, including the links to the appropriate business rules, and concluded that it is 'fit for purpose'.

3.0 Completion of Workgroup Report

During a brief onscreen review of the (draft) Workgroup Report (v0.5, dated 21 January 2015), BF advised that Section 3 – Solution reflected the amended modification as at 21 January 2015.

When asked, those present did not raise any concerns relating to the User Pays statement.

During a discussion on the relevant objectives, it was agreed by those present that objectives a) and b) would be furthered by implementation of this modification. BF made the necessary changes to the table. When asked, BF confirmed that it would not be necessary to amend the modification again to include the changes to the relevant objectives as these are captured within this report.

BF then amended the implementation statement to include 'date' after the '.....Project Nexus implementation' statement.

BF advised that the legal text and supporting commentary would be included within the report following the meeting.

Thereafter, the Workgroup reviewed and concluded the Workgroup Report.

BF confirmed that the Workgroup Report would be submitted to the March UNC Panel meeting for consideration.
