1. Review of Minutes and Actions

Opening the meeting, BF made reference to National Grid Distributions previous request that consideration of this modification be deferred until this meeting due in part to the impact of the Xoserve consultation on the potential deferral of Retrospective Adjustments and Unique Sites within the UK Link Replacement Programme (including Shared Meter Supply Points).

C Warner then advised that he expects that a new modification, seeking urgent status, would be raised the following day relating to elements of retrospective adjustments.

1.1. Minutes

2. Workgroup Report

2.1. Consideration of Legal Text

AC provided a brief overview of the recent amendments to the legal text pointing out that in paragraph 1.7.10(c) '20 Supply Point Systems Business Days' had been amended to read as '14 calendar days'.

When asked how this sits with the licence provisions, CW advised that this change is consistent with the provisions of UNC Modification 0477 'Supply Point Registration – Facilitation of Faster Switching'.

The Workgroup indicated that they were happy with the legal text as amended.

When asked, CW agreed to provide legal text commentary for inclusion in the Workgroup Report in due course.

2.2. Completion of Workgroup Report

During an onscreen review of the draft Workgroup Report (v0.2 dated 13 April 2015), BF made changes inline with discussions.

Thereafter, the Workgroup approved the report for submission to the 21 May 2015 Panel meeting, subject to National Grid Distribution providing a suitable legal text commentary.
