#### 1.0 Introduction and Status Review

#### 1.1. Approval of Minutes (12 April 2016)

The minutes of the previous meeting were approved.

**0401:** Xoserve to clearly clarify the unidentified gas reconciliation on the Treatment of Affected Offtake Reconciliation diagram between the old and new reconciliation rules. **Update:** MD provided a presentation (Impacts on Reconciliation and Unidentified Gas Reconciliation following Implementation of Modification 0578).

Reconciliation periods for SSP and LSP meter points during go live, retro updates interim arrangements phase and then following implementation of the retro updates functionality were illustrated and explained in greater detail by MD.
