1. Review of Minutes and Actions

1.1. Minutes

The minutes of the previous meeting were accepted.

1.2. Review of actions

UKL1209: CRN 962.7 - xoserve to establish how a change in definition from 'check meter' to 'secondary meter' can be accommodated and report back.

Update: DA reported that discussions have taken place. He indicated a number of issues with using the naming convention and the potential inconsistency. He confirmed that the approach proposed could not be accommodated due to data models and user interfaces - in order to change the terminology used Xoserve would need to apply a number of system changes. MD highlighted that this would cause an inconsistency in the terminology used. DA confirmed any such system change would incur costs. MB suggested the documentation is updated within SPAA and references made that Conquest and Xoserve systems use the terminology 'check meter'. **Closed.**

MB enquired about the Third Energy Package changes. DA provided a brief update and confirmed he would provide a further update within the change pack. It was confirmed that discussions are taking place within the Distribution Workgroup Meetings.

3. UK Link Modification Implementation Plan

Current UK Link Changes awaiting scheduling – Not Implemented

3.1. CRN 2005 - Exit Reform Phase 3

No further update.

3.2. CRN 962 – Query and Workflow Management

No further update.

3.3. CRN 962.6 Q&WM Proposed Removal of QEX File

Discussed at the CEUG, 15 March 2011, the CEUG have confirmed the process to be followed. A file format communication will be issued on 15 April 2011.

3.4. CRN 962.7 Q&WM - Q Communications

No further update.

3.5. CRN 962.10 – Q&WM Proposed Change to Theft of Gas (TOG)

Discussed at the CEUG, 15 March 2011. No subsequent issues raised on the number of fields, communication issued. Committee members provided consensus approval.

3.6. CRN 962.18 - Proposed Changes to Filter Failure (USRVs) Process

Discussed at the CEUG, 15 March 2011. No changes for filter failures file formats to be issued. Committee members provided consensus approval.

3.7. CRN 962.19 – Proposed Change to Request for Adjustment (RFA/CDQ/UMA) processes

Discussed at the CEUG, 15 March 2011. DA confirmed a new communication was required for a new record type as there will be some changes, and that notification will be provided.

3.8. User Pays Adhoc Invoice Type

DA confirmed that xoserve had issued the proposal for a mid May Class 1 change for formal representations. No representations received. DA requested final approval to move to scheduling. Committee members provided consensus approval.

3.9. CRN 2156 – Mod317 – UK Link Committee communication new adhoc charge types

DA reported that the change communication had been issued with a positive response. DA requested final approval to move to scheduling. Committee members provided consensus approval.

3.10. New Rejection Code for DN Interruption

DA reported that a change communication had been issued. The change is required to remove LDZ interruptible sites and a new rejection code would be required. He explained that this needs to be introduced by 17 July 2011. Xoserve sought views from the committee and requested formal approval. DA explained the use of the new code under Modification 0367. TD clarified that a firm site would not be able to be nominated as interruptible after the Modification 0367 implementation date. Committee members indicated that approval would be considered at May's meeting.

DA agreed to clarify the exact circumstances of when the code will be used and seek approval for the change in May. He confirmed that Xoserve would continue the preparation for the change.

New Action UKL 0402: Xoserve to clarify the use of the New Rejection Code of DN Interruption and seek approval for the change at May's UKLC.

DA reported successful implementation on 10 April 2011.
