# 2. Review of Minutes from previous meeting (30 July 2014)

### 2.1. Minutes

The minutes from the previous meeting were approved.

### 2.2. Actions

### 3. Climate Change Methodology – Hawarden Datasets

FC confirmed that the datasets had been published a week or so ago and no comments had been received. The remaining data files have now been received from the Met Office, including a slightly updated Temperature file. Following validation Xoserve will publish and request comments. CI observed that those published so far appeared satisfactory.

Next Steps

FC confirmed that the intention was to sign off/approve the datasets at the next meeting (22 September).

### 4. 0451AV Draft Pre Payment Meter (PPM) Profile

It had taken some time for parties to extract data for analysis, and it was noted that Xoserve was now working on this. The analysis, if ready, would be published prior to the next meeting.

The approach to analysing the data was discussed. The two datasets had been received from British Gas and E.ON. Potentially different profiles were possible. Methodology and derivation of the PPM Standard ALPs was discussed. The data from the 2 Shipper files would be combined into a single profile per LDZ, without weighting.

BF reminded that DESC must report on this to the September UNC Modification Panel.

### 5. Gas Day Change Update

The updated document was reviewed. FC drew attention to various points of note.

Weather Data – Use of observations 05:00 – 03:00

This was still under discussion with the Transporters.

Sample Data – Transition Considerations

Referring to switching of AMR Sample (Bands 1/2), FC reported that the Service Provider needed to do more work on this to ascertain how best to proceed, and had recommended a phased approach to implementing the hour change.

Appendices 1 and 2

FC had added these to provide clarity as to how the data is to be used and to

provide an audit trail for key decisions.

FC reiterated that it had been confirmed with the Transporters that 30 September 2015 was to be a 23 hour Gas Day and that 01 October 2015 will be a 24 hour Gas Day (05:00 – 05:00).

# 6. NDM Demand Estimation Methodology - Updated UNC Related Document

Outlining the background to this document, FC described the changes made to make this consistent in format with other UNC related documents. No changes had been made to the content. No comments had been received since the last meeting and DESC agreed this could now be approved.

It will take effect from the Project Nexus implementation date. It was noted that Spring Approach for the coming year may therefore be a hybrid, and that old and new DAFs may have to be prepared.

The document is capable of change and approval through the UNCC.

### Next Steps

FC will return the document to National Grid Distribution confirming that version 6 had been reviewed by DESC. National Grid Distribution will then present it to Project Nexus Workgroup.
