1. **Introduction and Status Review**

1.1. Minutes (25 February 2016)

The minutes of the previous meeting were approved.

1.2. Modification(s) with Ofgem

SH explained he was on a 'listening brief' only for this meeting. He agreed to investigate the status of Modification 0532, which was currently being evaluated by Jon Dixon. BF stated that this was linked in with Project Nexus transition and the industry would appreciate the certainty of a decision.

Pre-Modification discussions - 'Implementation of Non Effective Days to 1.3. enable AQ16'

DA explained that Scotia Gas Networks had raised this change previously, regarding 2015 AQ review in the event that Project Nexus did not go live in October 2015, hence why this modification was being raised again, with the same reasons as the previous modification.

DA moved on to explain that the AQ's processing timeline was going to have to be extended to 4 non effective days and he explained the timeline schematic in relation to File submissions. BF asked if Modification 0532 was implemented, then how would this new modification work? DA said it would sit alongside the original modification in case of a Go, No Go decision. BF then suggested that more detail was required to answer these types of questions, as it could be deemed as an alternate with potential conflicting issues with the original modification, together with the potential impact, if both were implemented at the same time. Both DA and HC requested feedback from the participants regarding this area, and proposed that there were challenges on the time-line's as the Industry required a level of certainty. DA confirmed he would investigate both Modifications 0532 and 0535 and provide assurances on status, if one should be implemented.

5. Any Other Business

5.1. Sub-deduct configuration reporting

SG overviewed the 'Sub Deduct Meter Arrangements' presentation and provided an explanation of the recent review of sub-deduct configured sites and the progress made so far. CB asked where the information was coming into the process, as Shippers were not getting all the specific data that was required. SG explained the information was inputted into CMS and then Xoserve forwarded the information to shippers with the required actions. CB said this was not always happening and so some of this information was missing. A lengthy discussion then ensued and DA proposed he would investigate this matter further in relation to the MPRNs, which would be downstream of an MPRN on an adopted network. SG explained that the remaining 129 sub deduct sites would be reengineered or adopted during 2016/2017, which would mean these would then be completed.

New Action DX302: Xoserve (DA) and National Grid Distribution (AC) to investigate how the management of meters and meter points on sub deduct arrangements are managed and reported.

Further discussion took place concerning the adoption of the Primes and Subs pipework and the overall ownership criteria in relation to the MPRN and network ownerships.
