## 2.1. UK Link Modification Implementation Plan

# 2.1.1. Current UK Link Changes awaiting scheduling – Not Implemented

#### CRN 2005 - Exit Reform Phase 3

AS reported that the change is on schedule, he confirmed that Xoserve need to firm up the implementation date with National Grid NTS, which is currently proposed as 29 July 2012, an update will be provided next month.

DA explained that information will be issued on 14 October for representation on the Gemini and API guidelines. Xoserve will be replacing existing guidelines, refreshing 5 API specifications and changing the Exit Regime invoicing file format. An external screen pack to support the new regimes is being produced for representation.

DA confirmed the plan to issue the rejection codes for representation on 14 October 2011. He explained that detailed analysis on the transmission of reports is being undertaken, the change will be notified in line with an operational Class 2 Change and any comments will be welcomed on the communication to be issued.

# CRN 0970 – Revised DN Interruption Requirements – Updates to Attributes within the DNI Exercise & Option Supporting Information File

DA reported that comments have been received accepting the change. Implementation will be on the 05 November 2011, Xoserve will be issuing a note on 14 October summarising the changes being made. The Class 1 Change was approved.

#### CRN 1721 - Extension to EUC Numeric Code

DA reported that the existing 4 characters have been exhausted; prior to 2012 AQ process the field needs to be extended to 10 characters. He explained that a significant number of files and records would be impacted by this change including SPAA processes, S10, S15, S59, S64. The plan is to implement on 01 August 2012 and a note will be issued on 14 October. DA reported that Xoserve would be seeking approval for an early implementation in July. This will allow parties time to adapt to the changes for 01 August 2012.

# CRN 2087 – AUGE Invoice Changes

DA reported that the UK link change is in response to a modification implementation; normally this would be a Class 2 Change however Xoserve propose a Class 1 Change

1 April 2012. There was no objection made to this proposal. Xoserve confirmed this will be issued for representation.

DA confirmed that Xoserve would provide a Strategic Initiative communication and a Change Pack update.

# 3.1. CRN 1000.9 – IX Upgrade (IX Kit Replacement) and CRN 1000.1 Introduction of Enhanced File Transfer (EFT)

DA reported that the upgrade continues and that the date remains as previously reported. More information will be provided when available.

#### 3.2. Project Nexus

DA reported an update will be provided on the main topic streams.

#### 3.3. IAD Project

DA indicated a 21 Jan 2012 implementation date, he confirmed that sample screens are intended to be provided in November, there has been a slight delay in the build, however the detailed design is to plan and a further update will be provided November.

## 3.4. Q Project

JR gave an update on the Q project referring to the Xoserve presentation provided.

The estimated delivery will be in two phases: Phase 1: May 2012 and Phase 2: July 2012.

JR explained that a number of topics will need to be discussed and these were provided within the presentation. An extensive review of file formats will be provided at the November UK Link Committee meeting. A CEUG meeting will be taking place on the 26 October.

DA believed it would be helpful if views can be provided on the expected notice periods i.e. a 4 month period will not required if an absolute confidence is provided; any signals to accept reduced notice period will help prioritising the project.

GW explained that prior to implementation British Gas will need to mobilise training or awareness of screens to numerous users and this can be difficult with date changes, he confirmed that British Gas will need a proper roll out period. JR believed by the end of November Xoserve will have a better of view of the dates. She requested if Shippers can give an indication for how long they needed for training, GW expressed this would be dependent on the style of training required.
