

Modification 0510 - Suggested legal text

EID Section A¹

Paragraph 1.3.3

In paragraph 1.3.3 remove bold text from the word 'forward'.

Amend paragraph 1.3.3(a):

"(a) Nominations may be made by, and quantities allocated (as UDQIs or UDQOs as the case may be) to, Users in the opposite reverse Direction (~~the reverse Direction~~) only as to rates and quantities which do not exceed the rates and quantities in which gas is nominated or allocated by or to Users in the forward Direction;"

~~(f) for the avoidance of doubt Users may be liable for Scheduling Charges and Commodity Charges in respect of the Interconnection Point (in respect of Interconnection Point Nominations and UDQIs or UDQOs as the case may be) in the reverse Direction.~~

Delete paragraph 1.3.3(e) and replace with:

(e) quantities will be allocated in the reverse (and forward) Directions in accordance with Section D;

Amend paragraph 1.3.3(f):

(f) for the avoidance of doubt Users will ~~may~~ be liable for ~~Scheduling Charges and Commodity Charges in respect of the Interconnection Point (in respect of Interconnection Point Nominations and UDQIs or UDQOs as the case may be)~~ in the reverse Direction.

Insert new paragraph 2.3.5:

"2.3.5 Except in relation to a Day on which (where permitted as referred to in paragraph 1.3.1) physical flows of gas occur at an Interconnection Point in both Directions (at different times on the Day):

- (a) the Direction in which physical flow occurs is the **forward** Direction;
- (b) the other Direction is the **reverse** Direction."

EID Section C²

Amend paragraph 1.6.2:

"1.6.2 For the purposes of any provision of the Transportation Principal Document other than a provision in TPD Section C, and for the purposes of Section D of this Document, a reference to Nominated Quantity in respect of any Day, User, Interconnection Point and Direction is to the sum of the Nominated Quantities under each Interconnection Point Nomination made by the User for that Day, Interconnection Point and Direction."

EID Section D

Insert Section D into the European Interconnection Document in the form attached.

Transition Document - Part VA

Insert new paragraph 5:

"5. EID Section D

- 5.1 The provisions of EID Section [DG](#) shall be effective from the Gas Flow Day ~~{1st October}~~ 2015.
- 5.2 For the purposes of EID Section D1.2.1(e):
 - (a) subject to paragraph (b), for each Interconnection Point, the Cumulative Steering Difference is zero for 30 September 2015;
 - (b) in relation to an Interconnection Point which is established after 1 October 2015, the Cumulative Steering Difference is zero for the Day before the commencement of commercial operations at the Interconnection Point as determined under the Interconnection Agreement."
