Communication	Notice of changes to invoicing arrangements for National Grid Gas plc and National Grid Gas Distribution Limited

Dear Colleague,

As of the 1 October 2016 National Grid Gas plc (NGG) 'hived out' its gas distribution business to a group company, National Grid Gas Distribution Limited (NGGD).

Currently invoices continue to be issued in the name of NGG for Transmission (NGG) and Distribution (NGGD) Transportation Charges in accordance with the transitional provisions set out in UNC Modification 0592S. This arrangement is a temporary solution and will expire at the point at which separated invoicing is achieved.

NGG issued an industry communication on 4 November 2016 which confirmed the lapsing of the UNC transitional provisions introduced by UNC Modification 0592S with effect from 1 January 2017, in line with the implementation of the solution agreed by the UK Link Committee for Legacy systems operated by the Transporter Agency, Xoserve.

Therefore, for invoices raised from 1 January 2017, payment for these will be made to the respective companies directly in accordance with the terms of the relevant invoice.

The introduction of separated invoicing on 1 January 2017 for NGG and NGGD will also introduce changes to the UK Link short code for NGG, which will be allocated the new short code 'NTS'. The 'TGT' short code will be assigned to NGGD for invoices issued from 1 January 2017. Shippers may need to update their systems to reflect this change.
