Re. The Queen on the application of Excelerate Energy Limited Partnership and Seal Sands Gas Transportation Limited -v- Gas and Electricity Markets Authority

On 29 June 2007, Excelerate Energy Limited Partnership and Seal Sands Gas Transportation Limited (together "Excelerate") issued High Court proceedings in London seeking permission for judicial review of the following:

- 1. The Gas and Electricity Markets Authority's ("GEMA's) decision dated 30 March 2007 to reduce amend NGG's NTS Licence to reduce baseline entry capacity at Teesside from 761 GWh/day to 361 GWh/day;
- 2. GEMA's 12 June 2007 rejection of proposed modification 151A to the Uniform Network Code ("UNC");
- 3. GEMA's ongoing failure to ensure the introduction of a baseline capacity transfer mechanism;
- 4. GEMA's ongoing failure to ensure revisions to the interuptibility regime in the UNC to satisfy the requirements of the Teesside GasPort; and
- 5. GEMA's ongoing failure to ensure that the energy arrangements for the NTS enable the GasPort to operate as planned

Excelerate is seeking the following remedies from the Court:

- 1. An order quashing the decision of 30 March 2007 reducing the baseline entry capacity for Teesside.
- 2. An order quashing the refusal of proposed modification of 151A.
- 3. A mandatory order requiring GEMA to introduce a capacity transfer mechanism forwith.
- 4. A mandatory order requiring GEMA to take steps to ensure that NGG complies with its undertaking given on 4 May 2007 to propose a modification to the UNC to revise the interuptibility regime so as to satisfy the requirements of the Teesside GasPort and requiring GEMA to ensure that such revisions are introduced into the UNC.

A mandatory order requiring GEMA to consider what modifications are required to the NTS entry arrangements (including amendments of the Teesside baseline entry capacity level) so as to enable the Teesside GasPort to operate as planned, and to take steps to ensure that such modifications are introduced.
- 6. Remittal of (1) and (2) for reconsideration.
- 7. Costs
