Re: UNC Modification Proposal 0506 0506A: Gas Performance Assurance Framework and Governance Arrangements

Thank you for the opportunity to provide representation of the above noted Modification Proposal. Northern Gas Networks (NGN) supports both Modification Proposals. Please find below NGN's comments in respect of the Modification Proposal.

NGN supports both Modification proposals with a preference for 0506A.

Summary of key reasons:

These modifications seek to introduce a Gas Performance Assurance Framework to be used to facilitate assurance and incentivisation of settlement accuracy post-implementation of Project Nexus.

Aside from the three year sunset clause in Modification Proposal 0506A, the main difference between the two proposals is the alternate names Xoserve as the Performance Assurance Framework Administrator (PAFA) while Modification Proposal 0506 seeks to run a procurement exercise to determine who fulfils the role.

NGN believe it will be more efficient to allow Xoserve to fulfil the role of the PAFA and for that reason support Modification Proposal 0506A over 0506.
