# 532 - Modification

- A modification has been proposed requesting [seven] Non Effective Days around Project Nexus Implementation Date.
  - Days proposed are Saturday 24<sup>th</sup> to Friday 30<sup>th</sup> September 2016
- In the main impacts are to sections G and M...
  - Processes defined are:
    - SPA - Supply Point Enquiry, Supply Point Nomination, Supply Point Offer, Supply Point Confirmation, Supply Point Objection, Supply Point Withdrawal, request for Isolation, application to increase or reduce Supply Point Capacity, Revisions to Annual Quantity or Supply Point Offtake Rate
    - Meter Reading - NDM Meter Reading and
    - Metering (RGMA) - Meter Information Notifications (ONJOB) and Meter Information Update Notifications (ONUPD)
  - Sample timelines have been presented to Nexus WG (PNUNC)

# 532 - Impacts

- Some suspended processes have liabilities associated with them
  - E.g. Offers / Referrals
- Additional liabilities required to be suspended due to unavailability of systems
  - E.g. Query Standards (S 4.7.3-6) as CMS is unavailable
- A number of liabilities relate specifically to UK Link Systems and Committee

# 532 – Impact to UKLink Committee

- Liabilities
  - U 7.6.7c - upon Transporter Request, UKLC may suspend obligations to make payment
  - System Failure and Non system Recovery
    - UK Link Failure exceeding 5 hours will pay £50 to each Affected User
      - ANS / Gemini - **Retain**
      - UK Link Network (I'X) – **Request Suspension** – Gemini files processed as BAU, Non Gemini Files UK Link not processed
    - UK Link Failure exceeding 24 hours will pay £1000 to each Affected User
      - ANS / Gemini - **Retain**
      - UK Link Network (I'X) – **Request Suspension** – Gemini files processed as BAU, Non Gemini Files UK Link not processed
    - Batch Transfer is unavailable for period greater than 24 hours than specified will pay £1000 per Affected User – **Request Suspension**

# 532 – Impact to UKLink Committee

- Liabilities .. continue
  - File Formats – Consultation – must provide representation period – **Retain Liability**
  - Failure to Implement Notice – **Retain Liability**
