1. Roles of Joint Office of Gas Transporters and xoserve

JB gave a brief overview. The effect for UK Link Committee is that the chairmanship and secretariat has transferred from xoserve to Joint Office and the UNC "Chairman's Guidelines" will now be used. Xoserve will continue to provide UK Link services to transporters as set out in the published UNC <u>Agency Services Agreement</u>, including provision of reports to UK Link Committee and consultation on UK Link System Modifications.

4.1 Gemini Progress (MN)

Progress items

MN indicated there would be a testing environment for IX upgrade associated with Gemini implementation.

7. File Format and Urgent Communications

8. Matters discussed under Any Other Business

8.1 ADH Invoice Type description query (MC)

MC reported an inconsistency within the documentation as regards the number of Z09 records to expect.

Xoserve clarified that multiple Z09 records could be received, and that the hierarchy diagram needed to be updated and reissued.

Action: xoserve to update ADH hierarchy documentation and notify.

8.2 Population of mandatory fields where mandatory data is not available (MC)

xoserve confirmed that the issue that MC had identified with the test files associated with non population of address fields was a matter that was confined to the test data. Xoserve confirmed that the live environment would be populated so all mandatory fields would contain data.

8.3 Version control on xoserve web site (HD)

HD reported that different version 3 and version 1 of U02, U03, U04 and U10 were posted.

Action: xoserve to ensure that only the current version is displayed as such.

8.4 Revised schedule of UK Link Committee meeting dates (JB)

The UNC Committee of 19th May (am) suggested that routine meetings of the UK Link Committee meetings should be scheduled such that UNC Committee has much less than one month time lag before it has opportunity to discuss reported progress. There was a consensus that UK Link Committee meetings should move to the second Thursday of the month, 10am. This is not possible

for June as this would disrupt the File Format consultation cycle, but the change can be implemented as of 14th July 05.

Action: Joint Office to arrange and notify revised schedule of UK Link Committee meeting dates (see 9 below).

8.5 Network Code Section U UK Link Modification Classes (JB)

The UNC Governance workstream has identified the need to review the drafting and implementation of Section U of the Uniform Network Code and asked this to be brought to the attention of attendees of UK Link Committee. Several attendees expressed some interest.

Action: Joint Office to make arrangements for a Governance Sub Group meeting on this topic the later of 11:30am or the conclusion of UK Link Committee on 14th July 05, and notify interested parties.

8.6 Provision of Testing Services for Electronic Code Communications UNC Review Proposal 001(650) (MP)

There have been few responses to date to the questionnaire. It was agreed to reissue this with a closing date for responses of 31st May 05.

Action: xoserve to reissue questionnaire (done 20 May 05) and pass any responses received to Scottish Power.
