Details of Service Change	The Service is for the provision of iGT Customers Data to Xoserve
	This service will be delivered in two parts:
	The installation and set-up of the Information Xchange (IX) communications mechanism and configuration of EFT to manage all file transfers.
	 The on-going maintenance cost of the communication service until such times as the implementation of the iGT Agency Services initiative.
	This will enable Xoserve to submit the iGT Customer Data to the DCC for the Smart Metering Programme. This aspect is not part of the Change Order and is included for explanation purposes only.
Does Xoserve consider Service Change can reasonably be implemented?	Xoserve will install a secured IX communications mechanism at each iGT organisations premises (there are 5 iGT organisations which between them have 10 iGT licensed entities) that will meet the requirement to transfer Smart Data in a secure manner to Xoserve.
	Xoserve considers this Service Change can reasonably be implemented.



Design Option (including timescales)	To enable Xoserve to submit the iGT Customer Data to the DCC for the Smart Metering Programme, files will be passed between iGTs and Xoserve and vice versa, using the Information Xchange Communication Mechanism (IX).
	The delivery timescales are anticipated to take in the region of 14 weeks. This is dependent on the type of kit required as part of the installation activity. That will be confirmed following site surveys at all iGT organisation premises.
	The IX installation activity will be instigated by Xoserve following the receipt and acknowledgement of Service Request.
Estimated development and implementation costs of each Design Option	The cost for implementing the recommended solution option for Change Order UPC0008 'iGT Customer Data Provision Service' is expected to be in the range of £161,974 to £208,066 (Inclusive of two years maintenance) for the full delivery of this change.
Estimated ongoing service costs/price (and cost recovery mechanisms) of each Design Option	Two year maintenance costs have been included.
Any system constraints	None identified.
Any amendments which will be required to the wording of the Services Schedule	Addition of a service to the Services Schedule for the Provision of non-Code User Pays Services.
