#### 1 Summary

### Is this a Self-Governance Modification?

The Modification Panel determined that this is a Self Governance modification as the low numbers of relevant Supply Points is unlikely to have material effect on gas consumers; competition or the operation of pipe-line systems.

## Why Change?

Modification 0477, Supply Point Registration - Facilitation of Faster Switching implemented on 07 November 2014, enabled 'faster switching' to take place for all Supply Point categories with the exception of Shared Supply Meter Points (SSMPs). Workgroup 0477 excluded SSMPs from the scope of Modification 0477 as the Shipper User transfer process is dealt with manually under the 'unique sites' procedures. Now that the systems requirements and impacts for SSMPs are understood, it is timely that this modification be progressed which would bring the Shipper User transfer timescales for SSMPs in line with all other Supply Points.

#### Solution

Modification of the UNC is required to amend the obligation contained in TPD Section G1.7.10 from a minimum of 20 Business Days to a minimum of 14 Calendar Days for SSMPS.

#### **Relevant Objectives**

The modification would reduce the minimum timeframe for the change of Shipper User Registration for SSMPs. A guicker process would increase consumer confidence and engagement in the change of Supplier process and thus be expected to better facilitate Relevant Objective d) Securing of effective competition between Shippers and Suppliers.

#### Implementation

This modification would be implemented in line with the Project Nexus Implementation Date, as this is when the revised Shipper User transfer timelines under Modification 0477 will take effect.

This modification would be delivered in conjunction with the Project Nexus programme and has no impact on the Significant Code Review.

## Does this modification impact a Significant Code Review (SCR) or other significant industry change projects, if so, how?

This modification would be delivered in conjunction with the Project Nexus programme. The SCR is not impacted.

#### 2 Why Change?

Modification 0477 - Supply Point Registration - Facilitation of Faster Switching implemented on 7th November 2014 was raised as a consequence of a Government initiative to reduce the change of supplier timescales within the UK. This initiative did not distinguish between Supply Point categories and so implementation of this modification would ensure compliance with the Government initiative.

The UNC was amended under Modification 0477 and UNC TPD G2.5.8b was revised to change the minimum timescales for transfer of Shipper User Supply Point ownership from 20 Business Days to 14 Calendar Days.

Modification 0477 enabled 'faster switching' to take place for all Supply Point categories with the exception of SSMPs. The 0477 Workgroup sought to exclude these from the scope of 0477 as the Shipper User transfer process is dealt with manually. It was known at the time of 0477 development that the 'unique sites' processes relating to SSMPs would go 'on-line' with the implementation of the Project Nexus UNC Modifications. As a result it was identified that a separate UNC Modification to align the shipper transfer processes should be considered in due course. This is the modification referred to within the 0477 Workgroup developments.

UNC TPD Section G1.7.10 sets out the corresponding minimum timescales for Shipper User transfer of Supply Point ownership at SSMPs. This obligation currently stands at 20 Business Days. Therefore G1.7.10 is required to be amended from 20 Business Days to 14 Calendar Days.

This would bring the Shipper User transfer timescales for SSMPs into line with all other Supply Points.

## **3** Solution

Modification of the UNC is required to align the Shipper User transfer timescales for SSMPs to that of all other Supply Points. It should be noted that the amendment would solely reduce the minimum timescales for the submission of the Supply Point Confirmation from 20 Business Days to 14 Calendar Days, it does not affect the maximum period for the submission of the Confirmation.

## Solution

Modification of the UNC is required to amend the obligation contained in TPD Section G1.7.10 from a minimum of 20 Business Days to a minimum of 14 Calendar Days for SSMPS.

## **Business Rules**

The proposed Supply Point Registration Date shall be not less than 14 Calendar Days commencing on the Day after the Supply Point Confirmation is submitted. G1.7.10 – (Currently 20 Business Days)

In a similar manner to Modification 0477, implementation of this modification would facilitate Relevant Objective d) Securing of effective competition by reducing the minimum timeframe for the change of Shipper User Registration for SSMPs, in turn providing benefits for consumers as they would be able to change their Supplier considerably faster than under the existing arrangements. A quicker process would increase consumer confidence and engagement in the change of Supplier process and thus be expected to better facilitate effective competition between Shippers and Suppliers.

Associated systems and process changes to enable this to happen would be included within the Project Nexus Project therefore additional costs would be kept to a minimum.

## **5** Implementation

This modification is required to be implemented in line with the Project Nexus Implementation Date. Relevant systems and process are presently being developed to facilitate implementation.

#### Suggested wording for Modifications:

The Workgroup has not proposed a timescale for implementation of this modification, but would suggest that it is implemented at the earliest practical opportunity.

#### Suggested wording for Self-Governance Modifications:

As self-governance procedures are proposed, implementation could be sixteen business days after a Modification Panel decision to implement, subject to no Appeal being raised.

#### Suggested wording for Fast Track Self-Governance Modifications:

As fast track self-governance procedures are proposed, implementation could be sixteen business days after a unanimous vote in favour of implementation by the Modification Panel, subject to no objection being raised.
