The Workgroup Report is due to be presented at the UNC Modification Panel by 17 May 2018.

### 1. Introductions

BF welcomed colleagues to the teleconference meeting. He sought clarification of expectations for the meeting as a number of late papers had been submitted and published on the day of the meeting. He explained that this short meeting had been arranged to provide an update before the face to face meeting scheduled for 13 November 2017.

Concern was raised that insufficient time had been provided to read the papers. SM considered that the paper provided by the AUGE titled *UIG Calculation Issue* – *Analysis* was important and critical to the discussion and therefore needed a debate before the next meeting on 13 November 2017. BF explained that the AUGE paper had been discussed at the PAC meeting on 01 November 2017 and PAC considered that the issues raised in the paper were more pertinent to Workgroup 0631R. The paper would act as a reference point, raise awareness of the issues and facilitate discussion. AL stated that this was an unsolicited paper from the AUGE in response to an action from PAC. BF advised that the AUGE had submitted a paper based on the request for UIG related information contained in the key messages from the October 2017 PAC meeting.

The Workgroup agreed that this paper should be discussed in full at the meeting on 13 November 2017. The additional papers provided for today's meeting to be deferred to a future meeting.

In response to a suggestion that a meeting was needed before 13 November to discuss the AUGE paper, BF explained that the AUGE in response to the comments received at the PAC meeting were going to provide a further iteration of this paper and it might be challenging to expect this before 13 November 2017. It was agreed that the current version of the AUGE paper would be discussed at the next meeting and AUGE may wish to attend.

#### 2. Update of the provision of meter read information

LW confirmed that the daily call meetings would be added to the Joint Office event diary. In terms of the data provision, she directed colleagues to the slide in the *UIG Update* paper which encouraged Shippers to undertake a data cleanse exercise before submitting their full year data to Xoserve. Shippers are specifically asked to remove duplicate records, ensure that each row contains a value in each of the mandatory files and remove any unnecessary records (those that fall outside the require period of 25/09/17 to 01/10/17). In response to a question she confirmed that it was daily consumption data and not daily read.

LW gave a brief overview of the NDM daily reads submission timeline confirming that all data from Shippers is required by Friday 10 November 2017 in order for Xoserve to complete their actions. The original deadline of 03 November 2017 has been extended to allow responses from a number of Shippers who have indicated their intention to provide a return.

The daily UIG calls which have been set up are intended to provide a quick update only and not intended to replace the longer scheduled meetings. The Workgroup agreed that these daily calls should be used to discuss actions arising from the longer meetings.

## 4. Next Steps

BF asked the Workgroup what additional meetings are required to move forward the work in order to produce a Workgroup report for Panel by 17 May 2018 or earlier. As a result of the discussion it was agreed that:

a. The 13 November 2017 meeting would now focus on a deep dive of the AUGE paper.

- b. It was suggested that meetings could coincide with DESC meetings as they covered similar ground. The meetings scheduled 21 November and 11 December 2017 could therefore be used to discuss analysis and additional papers that were not discussed at this meeting and any other issues that needed consideration.
- c. In addition, it was agreed to hold Thursday 30 November 2017 should a further face to face meeting be required.
- d. The position would be reviewed following the meetings on 13 and 21 November 2017
