- 01/11/17 2.1 Xoserve (LW) to investigate the capability of Xoserve to manage and process a high volume of Smart Meter Reads and AMR data from Shippers.
- As per the data specification, Xoserve has suggested around 100 sites per Shipper per EUC per LDZ – this would equate to almost 50,000 meter points per Shipper and could be accommodated
- There is no limit as such but timeline to get submitted data cleansed is a factor and therefore there is a preference not to have tens of thousands and for the data provided to be in reasonable shape and reliable.


#### **UIG Resolution**



#### Key Messages

- Preparations for the Industry wide session on Monday 13th November are in progress and invitations issued to Industry participants
- DM Read rejections moved to Amber due to falling behind the baseline plan
- Xoserve continue to help the industry with RGMA flows.

DM Read Rejections	Progress has slowed in the resolution of the DM Read Rejections. There are 41 from Phase 1 and 32 from Phase 2 outstanding, A large number of queries are now awaiting site visit and RGMA updates from Shippers and we urge all Industry participants to resolve their queries as soon as possible.
Erroneous AQs	The proposal was presented at the Change Managers Committee on 8 <sup>th</sup> November and a window is now available for Shippers to challenge any of the MPRs where they do not want to apply to old AQ. The data fix is planned for 18 <sup>th</sup> November and code fix planned for 8 <sup>th</sup> December.
CSEP / LDZ Mapping	Following attendance at the DN meeting, the DN's will be engaging with the iGT's to ensure that the data we are holding is correct. We are unsure until this work has been completed, as to the scale and impact of any issues,
Analyse cause of volatility	Following an invitation from Ofgem, Industry participants are invited to a future UIG workshop on 13 <sup>th</sup> November to discuss the current ICoSS proposals and any other options as identified by 10 <sup>th</sup> November.





- The recent negatives on October 27<sup>th</sup> and 29<sup>th</sup> occurred in most LDZs and appear to be weather related rather than DM related



  - Part 3 Provision of reports to industry







# Proportion of AQ in WAR Bands – All EUCs 3-8<sub>12</sub>











# Proportion of AQ in WAR Bands – EUC Band 4 14
















# Proportion of AQ in WAR Bands – EUC Band 7 17
