The Workgroup Report is due to be presented at the UNC Modification Panel by 15 February 21018.

### 1. Outline of Modification

AM briefly introduced this modification which seeks to amend the rules to extend the portfolio reconciliation notice period, as and when the GDN Transporters deem that an industry reconciliation exercise is necessary. It is proposed to reverse the UNC Code obligation back to GDN Transporters, as the CDSP is a data processor not a data controller. The 20-day notice period is also considered to be too short for Shippers to make appropriate arrangements to

ensure that there is adequate resourcing to undertake the reconciliation exercise successfully. An extension from 20 days to 90 days is proposed.

#### 2. Initial Discussion

TC confirmed that the reconciliation exercise is currently on-going. AM in response stated that they have team resources available to undertake this work.

AM questioned who should trigger the reconciliation exercise? He explained that post the Xoserve Funding, Governance and Ownership (FGO) project removed the obligation relating to portfolio reconciliation from Transporters to the Central Data Service Provider (CDSP). The proposer believes this is incorrect and is seeking to move it back to Transporters. AM sought Transporters views on whether they should have the obligation.

The general view from Transporters was that they need to have sight of the wording of the legal text to inform discussion. In addition, RP stated that iGTs might ask for a reconciliation exercise next year but GDNs might not.

DA mentioned an issue in relation to UNC Modification 0431 *Shipper/Transporter - Meter Point Portfolio Reconciliation rules and obligations* where extracts on D-2 data duplicate data received leading to inconsistent reporting.

## 3. Next Steps

BF confirmed that the next steps are the development of the Workgroup report. He confirmed that a ROM is not needed as there are no central system cost implications. Legal text would be required to form the basis of the discussion at the next meeting.
