8. Review of Outstanding Actions

Action 1101: British Gas (JB) agreed to provide further analysis of the impact on UIG of incorrect WAR Bands on EUC (update of Paper Titled *Percentage of AQ in a Bucket Band instead of a WAR Band*).

Update: JB provided an overview of the *Post-Nexus Demand Response – National Results* presentation, in relation to the impact on UIG of incorrect WAR Bands on EUC. He explained the analytical data as detailed in the graphs, and explained that he had produced two simulations for the WAR Bands and the practical implementation of the WAR Bands. Action 1201: Xoserve (FC) to publish the educational pack and provide the link to their website for inclusion in the minutes as a post - meeting update.

Update: FC explained the Educational pack had been published before Christmas and links had also been sent to Shippers by the Xoserve Customer Account Managers. She noted that the Performance Assurance Committee (PAC) were also monitoring the results in respect of improvements in the proportion of sites being in WAR Bands rather than the Bucket EUCs. She said that the results were also going to be discussed in the March PAC Meeting. Update: All agreed this action could now be closed as this matter had now been investigated. **Closed.**

Action 1203: Xoserve (FC) to undertake analysis to compare actual allocations to the position once reconciliation has occurred.

Update: FC explained that this matter had been discussed in the UNC UIG Workgroup that was held on 30 January 2018. She provided an overview of the data analysis and reconciliation information presented and said that the raw data was being published on a monthly basis with the overall totals. CS also noted that further detailed discussions would be taking place at the next DESC meeting specifically in relation to the reconciliation process. MPal asked if the reconciliation analysis could be used to improve the NDM algorithm in some way. FC highlighted that the analysis presented earlier at DESC had been conducted to measure performance of the models and that until a complete Gas Year had elapsed definite conclusions could not be drawn. Differences seen so far could also indicate that the AQ used was too high or low.

CS said his aspiration for the next meeting was to complete the Workgroup Report.
