## 1 Summary

### What

UNC Modification 0638V is currently awaiting implementation, set for 1 April 2018. As a result of the compressed timescales requested to produce legal text, a typographical error was included in TPD M5.9.2(d), namely a capital “M” was incorrectly used when describing the Meter Read Frequency.

### Why

This correction will clarify that for sites with Smart or AMR devices able to remotely transmit reads, the shipper/supplier is required to obtain and submit a Valid Meter Read to Xoserve on a monthly basis, but is not required to change their system based Meter Read Frequency to Monthly, remaining Annual as noted in the solution set out in UNC0638V.

### How

It is proposed to amend “Monthly” to “monthly” in TPD M5.9.2(d) in order to more accurately reflect the solution set out in UNC0638V.

## 2 Governance

### Justification for Fast Track Self-Governance

As this modification only seeks to amend an instance of incorrect capitalisation, it is unlikely to have a material impact on any UNC party or process and is therefore proposed to be considered suitable for fast track self-governance.

### Requested Next Steps

This modification should:

- be subject to fast track self-governance, and
- be implemented.

## 3 Why Change?

The CMA, as stated in its Gas Settlement Order of 2016, directed that for sites with fitted with Smart or AMR devices able to remotely transmit reads, the shipper/supplier must obtain and submit a Valid Meter Read to Xoserve on a monthly basis, starting on 01 April 2018. A minor typographical correction to the legal text is required in order to clarify that the sites are not required to change their system based Meter Read Frequency.

## 9 Legal Text

### Text

The following Legal Text has been provided by the proposer:

#### **Amend Section TPD M5.9.2 as follows:**

(d) notwithstanding the above, where the Supply Meter Installation at a Supply Meter Point has or is comprised of a Smart or Advanced Meter, the Meter Read Frequency shall be no greater than ~~Monthly~~ monthly in any case and the Shipper User shall take all reasonable steps to obtain and submit a Valid Meter Reading at least once per month.

## 10 Panel Discussions

### Determinations

Members voted unanimously that Modification 0650 is suitable for Fast Track Self-Governance.

Members voted unanimously to recommend implementation of Modification 0650FT.
