	Paragraph 4.4.5	Definition of what constitutes a Conflicting Appointment in the context of both a Voting Member and its alternate; broadly being where the Member or alternate is employed or engaged by a person who is represented by a Member appointed by a different Panel Constituency.

Transition Document Part IV – Modification Rules		Rules added to make clear: - where Voting Members for the period commencing 1 October 2018 are appointed at the time Modification 0656 is implemented they will continue to be appointed for a one year period only, and will retire with effect from 1 October 2019, and the first two (2) years appointment will commence from that date; - the Secretary as soon as practicable issue the form of notice required from a Voting Member
		 and any alternate confirming they have no Conflicting Appointment; and the Voting Member or any alternate cannot attend a meeting of the Modification Panel or vote until the relevant confirmation is submitted to the Secretary; and Voting Members will appoint two (2) alternates as soon as practicable.
