
Xoserve shall provide a dataset to the AltHANCo service provider on a quarterly basis. The dataset will be provided via a shared area download facility e.g. Huddle. The AltHANCo service provider will use the data in accordance with the permitted purpose set out in the commercial arrangements. The AltHANCo service provider will be required to delete the data once the exercise is completed. It is not expected that any individuals will be affected solely by the dataset from Xoserve. It is however, expected that individuals will benefit from the overall service provided by the AltHANCo service provider in the form of a more efficient smart metering roll-out.


